E. Equipment Maintenance, Inventory

Sally worked on the shed theft report and damage to the main sheds and on the east side. She notified the police about the opening in the property boundary and let them know our City contact person is Chris. The officer interviewed gardeners who were witnesses. Shed hasps have been repaired with new locks. She was appreciative of Charlie who helped with the aftermath. Sally shared the inventory with him. Mary suggested that possibly we leave all tools at home and stop using locks to make it obvious we don't have anything important. (They did not want any of our tools or wheelbarrows.) Sally can come back to the board with suggestions from Chris and the police department. The new shelves in the gardening shed should be here in November and gardeners can help with the restructuring and cleaning out of the shed. Pat observed that there was some theft of vegetables- a watermelon and a loofah vegetable from the demonstration plot. Mary will send out a reminder that gardeners can only touch vegetables in their own plot and not other people's produce. Pat suggests greeting people at the garden to build more community so we know everyone better.

H. Rodent Control

Alfredo came last Thursday and found 3 dead gophers in plots 18, 59, and over by the little shed. He found a couple of flags out in the field that perhaps someone threw out there instead of leaving them alone in the plot. That could mean that their trap is still under the group in that plot. I told him I would send out a reminder to leave all flags and traps alone. The squirrel bait has not been touched much in the last two weeks meaning that the squirrel population is down. One plot had droppings of a larger animal, perhaps a cat or a raccoon, not gopher or squirrel. We do have rabbits running around which can be the pest nibbling at our zucchini. He suggested keeping up the service, because if we let up the pests will just return.

There were various activities throughout the garden. Alex and Charlie were exceptional helpers with canopy and sign set up, vegetable grilling, etc. The pollinator garden table and seed saving tables were very popular. Five or six people got seeds to take and plant. We had more people participating and next year perhaps there will be more members participating, borrowing of items from other non-profits. Alex's grilling of vegetables was greatly appreciated.

Changes Sue would like to see would be to have just water, and no tea. A more definite work schedule with times and a sign in sheet. She would like to have gardener contact information to make that easier, perhaps putting that on the registration form. Publicity with more online methods, like Mamabear, and our own internal Facebook. Our event was a bit affected by the untimely death of three people in our community. Mike Cox, Marty Cheek, and Rich Firato. Allen suggested having a drawing for a free bed for a new member, but we didn't do that this year. Charlie suggests we write an article for the newspaper and then put our announcement in there. (Morgan Hill Times, Life) Sally suggests some members donate one thing that has to do with gardening (gloves, etc.) and have a drawing. Pat suggests changing the time to 9-1 and Mary W suggests food sharing.
